

2008 Art Booth Application Conditions, Rules & Regulations



1. All artwork must be **ORIGINAL** and must be appropriate for family viewing.
2. Applicants must send a slide or photo of their art and of their booth with the Application and Exhibit Fee(s). Slides should be submitted in a plastic sleeve. All images will be returned to you.
3. Sending in an application does not imply automatic acceptance. All applications will be **juried** for uniqueness, quality, and product type.
4. Approval of applications, booth design, and/or booth location will be at the sole discretion of ArtSplash.
5. Acceptance of your medium does not constitute exclusivity.
6. Participants shall adhere to **setup time of Saturday, September 20th at 7:00 AM** and a **teardown time beginning Sunday, September 21st at 5:00 PM.**
7. Participants are responsible for supplying their own exhibit set up (tent, chairs, etc.) and tents **must be white,** 10 X 10 with sides.
8. Participants are responsible for set up and tear down of their own displays.
9. Participants must sell from their designated space only.
10. **All** Booths must conform to size restrictions on all sides and must not infringe on walkways or neighboring booth spaces.
11. Sharing a booth is NOT permitted.
12. Booths must comply with local fire codes.
13. All artists must have a California State Board of Equalization seller's permit, **or application cannot be accepted.**
14. No dogs or pets of any kind are allowed (except seeing eye dogs).
15. Alcoholic beverages are **prohibited** in booths and attractions.
16. ArtSplash shall assume no liability for damage to property belonging to participant(s).
17. **NO REFUNDS** will be issued once applications have been accepted and approved.
